III. Review and approval of plans

- a) Rouei 3402-361 2313 Freeman Dr SFR
 - 1. #10 tree was removed without permission from the ECC, and the architect couldn't remember what type it was. If the structure was rotated 20-30 degrees, the #12 tree at the rear of the property could be saved. The architect feels this would reduce future development in 5 years. There are four other trees, 7, 9, 11 & 16 may or may not need to be removed later on. The concept is that the owner will live upstairs and her son downstairs with access from outside the structure. There were also issues with the aesthetics of the design of the building. The owner can only afford to build the first phase now and the rest after she builds out the SFR on Lassen, sell it and finish the SFR on Freeman to be about 4,000 sf.

At this point, the majority of the committee denies the approval of the project.
