

PMCPOA Member Information Packet

Welcome to beautiful Pine Mountain Club, the "nearby faraway place." We have assembled some information as a brief overview to help you get acquainted with the Pine Mountain Club (PMC) Property Owners Association and the area surrounding us, and provided links to our web site for additional information. Do you know that life on "The Hill," as it is often referred to by people who live here, offers a wide array of activities, organizations, shopping, and more? We think you'll find this packet and our website very helpful.



If you are a new property owner, your membership card(s) should have been provided to you along with this packet. If not, contact staff at the business office located in the lobby of the clubhouse at 2524 Beechwood Way. Membership cards must be presented if requested by our staff when on Association property.

We request you complete and return the "Member Information/Email Update" and the "Property Access Authorization" forms (included within this packet). These forms assist the association in contacting you if necessary and keeping you updated on information, and provide (optional) authorization for staff to check your residence to verify that your house is secure in your absence or there is any suspicious activity or situation that could result in fire, theft, or damage to your property or house.

PMC and the Governing Documents

Pine Mountain Club was formed in the 1970's primarily as a vacation and retirement area. Over the years, the community has grown and evolved and is now home to full-time residents who commute into surrounding cities, are self-employed, or who have retired on the mountain. Many other property owners are "weekenders" who live and work in surrounding cities but come up to PMC periodically, or who use their homes as vacation or full-time rentals. Others own land here but do not have homes on their properties.

Needless to say, a system of governance is necessary to help keep Pine Mountain Club functioning smoothly and to maintain the peace and tranquility that its diverse members desire. Pine Mountain Club Property Owners Association, including its staff and Board of Directors, utilize a series of documents that define the rules and practices that must be followed in managing the community and its facilities. These documents include the Articles of Incorporation, the Covenants, Conditions and Restrictions (CC&Rs), Bylaws, and Association Rules which include an Environmental Control Code.

The Association Rules are established by the PMCPOA Board to outline proper usage of association property. They are changed or updated by the Board in keeping with evolving needs or changing laws. The Association Rules document contains a long list of general rules, animal control procedures, rules for filming in PMC, traffic regulations, proper use of the clubhouse and outdoor facilities, election rules and more.

We want members and their guests to enjoy our community – but it is important to know and understand that members and guests are expected to comply with the rules and governing documents - and the members are fully responsible for the conduct of their guests while within Pine Mountain Club (Rule 3.02). Failure to comply with the rules could subject violators to a citation and potential fines or penalties.

Do you know the "PMC Clubhouse" consists of the Condor (multi-purpose) Room, Condor Café, a cocktail lounge, a recreation room, Environmental Control Office, Patrol Office, Pro (Golf) Shop & Gifts, and the business office? An ATM machine is located in the clubhouse lobby. Membership or guest cards may be requested when ordering food or drink from the Lounge or Condor Café or when using association amenities (Rule 3.01).

A variety of recreational amenities are available through the association, including a recreation room with a small library, golf, equestrian center, swimming pool, tennis and pickleball courts, hiking trails, and Lampkin Park with a softball field, barbecue and picnic areas, courts for basketball, beach volleyball, bocce ball, and more:

Pine Mountain Club Patrol

PMC Patrol monitors the safety of the community by patrolling the neighborhoods and responding to calls by members. Our PMC Patrol is not a law enforcement agency. The patrol office is located in the clubhouse and open 24 hours a day, seven days a week. During non-business hours, the Patrol Office may be locked, however, a Patrol staff member can be reached by phone. For emergencies requiring assistance or response from the Kern County Sheriff's Office, call 9-1-1.

The main objectives of the patrol (security) department are to enforce the association's rules set forth by the governing documents and the CC&Rs, and to protect the association's property. The patrol department does not provide law enforcement services. Our officers have been made available occasionally to assist in minor emergencies and to help our local first-responder agencies upon request and in times of a crisis.

Environmental Control Office

The Environmental Control Officer is an employee of the PMCPOA charged with enforcing the Environmental Control Code with a goal of maintaining the quality of the environment and the value of the properties. This includes, but is not limited to, construction, issuing permission for cutting indigenous trees, adding a structure, solar energy, and painting. Transfer Site

The Transfer Site is a convenient amenity offered to members and their guests to dispose of household trash, recyclables household batteries, cold ashes, and other items in lieu of driving to the waste disposal transfer station in Lebec. The Transfer Site includes a separate green waste area for yard cuttings - but no noxious weeds. There are no facilities at the Transfer Site for - and it is prohibited to - dispose of construction debris and material, hazardous waste, dead animals, explosives, poisons, pesticides, noxious weeds, infectious wastes, asbestos, tires, mattresses, and large furniture (Rules 18.06 & 18.07). These prohibited items may be transported to the Lebec transfer station.

Members and guests using the Transfer Site are required to recycle and separate items from the household trash, including ashes, aluminum, glass, cardboard, designated plastics, scrap metal, electronic waste, and appliances (Rule 18.14). Bins are provided to deposit recyclables and there is a designated area for cardboard.

The Transfer Site is open every day from 8:30 am to 5:00 pm with extended hours on Thursdays during the spring and summer to 7:00 pm. The site is closed on Christmas Day and Thanksgiving Day.

Do you know about the snow in PMC?

We are often surprised to learn that new members were not informed in advance or prior to their property purchase that it snows in Pine Mountain Club and the surrounding area. New members sometimes forget to share information about snow conditions with their guests or renters causing dangerous situations and hardships to occur when they travel or arrive. Local roads and Interstate 5 are sometimes closed due to snow and related weather conditions. Snow chains are often required. Post Office

US Postal Service is provided by PMCPOA through an annual contract with USPS and only delivers mail onsite to members' individual boxes assigned to the 93222 zip code. Members with a 93225 zip code receive their mail at the outdoor mailboxes located west of the intersection at Tirol Drive and Voltaire Drive. Visit the Post Office and complete the paperwork to obtain your box. There is no cost for a regular size box for members. For larger boxes and non-members, there is a rental fee.

The Post Office is located at 16321 Askin Drive. Hours are Mondays through Fridays from 10:00 am to 12:00 noon, then 1:00 to 3:00 pm, and Saturdays from 10:00 am to 12:00 noon.

PMCPOA email blasts share information and keep members informed about the association and the local area, and can include fire and weather alerts, entertainment information, Condor Café menus, special events, updates, messages from the PMCPOA general manager and board chair, and more. The result is that many requests to 911 do not involve true emergencies, which overloads the 911 system with non-emergency calls. Los Padres National Forest surrounds Pine Mountain Club. Encompassing almost two million acres, Los Padres is the third largest National Forest in California. It occupies a major portion of the coastal mountain ranges and extends for about 220 miles from the west boundary of Los Angeles County to mid-Monterey County on the north. Forest Adventure Pass or an Interagency Pass is <u>required</u> to park anywhere along Cuddy Valley Road, and in the parking lots at the Chula Vista Parking Lot (Chula Vista Trailhead) and at the "Y" at the junction of Cuddy Valley Road and Mil Potrero Highway east of Pine Mountain Club. The Forest Service tickets vehicles that are not displaying the passes so visitors should be prepared by purchasing an Adventure Pass. More information available at:

Do you know the origins of Pine Mountain Club?

There was a sawmill in the valley to harvest lumber for Fort Tejon before the Civil War. The Kern Land Company, incorporated in 1890, owned the property known as Mil Potrero Ranch and there are photos of cattle grazing on the spot being used today for our golf course. The Los Padres National Forest was established in 1908, but Mil Potrero Ranch remained in private hands.

Tenneco Corporation purchased the Kern County Land Company in 1967 and in 1971 began development of Pine Mountain Club. Once the development was finished and all lots were sold, Tenneco turned over the community to the Pine Mountain Club Property Owners Association.

The Board may respond to you either at the meeting or you may give a written request to have your question answered. Members are often allowed to provide input on specific agenda matters before the board votes and another opportunity to speak during Members' Rebuttal Forum following the Directors' Forum.

PMCPOA welcomes member input. It takes a village to run a village, and your feedback and concerns help keep PMC the wonderful place we love.
