- a) Gulin 3402-123 16701 Sandalwood Dr SFR Owner applied for a tree removal permit for the removal of 2 monument trees to build a home, which ECC originally denied. Contractor, Pat Banfield, on owners behalf, agreed to leave one of the trees but (#4) but explained that the #1 tree roots would be damaged during construction and also that is in the pathway of where the leach field will be. Motion by Mike Joseph is to approve the plans as submitted with the stipulation that #4 tree remains and that 4 additional 24" size boxed trees be planted on the property prior to the refund due at the end of the project. In addition, the "swale" in question is an old and unused swale and will not impact or cause to be impacted by construction. Addendum to original Tree Removal Permit attached to reflect changes made.
- b) Ohanyan 3507-297 15228 San Moritz Dr Lot Storage Mr Ohanyan attended the meeting regarding complaints that his lot is turning into storage for his construction materials and more specifically, fire wood when there's no home on the lot, however, the plan is to start building his SFR in the spring. ECC is allowing him to keep the fire wood if he moved it further back from the P/L and that he began building in the spring as stated, or he needs to get rid of the wood.
