1. Call Meeting to Order.

Meeting was called to order at 9:00 a.m. by Vice Chair Connie Baldin.

2. Approval of minutes for 4 February 2017 meeting.

MOTION by Finn Myggen, **SECONDED** by Grace Wollemann to approve the minutes of February 4, 2017. **MOTION** carried unanimously.

3. E.C. Code 7.22 D (1)

After a discussion by the ECC Chair Marianne Knapp, the governing documents committee agreed by consensus to the suggested rewrite of EC Code Section 7.22 D (1) as specified below:

1) As used herein, the term "Commercial vehicles" shall be defined as stated in section 5.11 of the CC&Rs. A commercial vehicle may only be temporarily parked on the lot or the street during the time the operator of the commercial vehicle is delivering goods or is providing services to the owner or occupant of the residence. Personal vehicles with advertising decals may be parked on the property, but in no case can any advertising decal be larger than 200 square inches (e.g. 12" x 16.6") and no more than three such decals on any personal vehicle. If a personal vehicle has any advertising decal larger than 200 square inches and/or more than three (3) decals as described above, it must be screened from view by an earth-toned cover or tarp, anytime it is parked on the property.
