

## 'Do I call PMC Patrol, or Kern County Sheriff?' Clarification on Who To Call When

PMC Patrol's primary duty is to protect and preserve Association property; however, we do assist property owners whenever possible. PMC Patrol is not a law enforcement agency, nor is it a private community security company. Home security is the responsibility of each individual property owner.

In the event of a criminal complaint, or if there is any kind of danger, always call 911 first! Then call Patrol second. If it is a situation that we aren't permitted to respond to, we will at least come to the area and be good witnesses and take descriptions, etc. to give the Sheriff's responders when they arrive. Most of the time the person needing help is too distressed to think of these details, so having another set of eyes is always helpful.

Remember, Patrol cannot call the authorities for you -- only the victim can report it. Only the victim will have the information the 911 dispatcher will need.

Civil complaints cannot be addressed by either Patrol or the Sheriff. Unfortunately, you'll have to contact an attorney for that. A civil complaint is any event that is not criminal in nature, like a property boundary dispute.

For an event involving a vehicle on the roads, the California Highway Patrol is the proper agency to contact. The sheriff handles all other criminal complaints.

### **Door-to-Door Salespeople**

Door-to-door solicitation is not allowed in PMC. If a person

## Tips on How To Safely Heat Your Home

*Emergency Preparedness Committee*

Heating equipment is one of the leading causes of home fires during the winter months. With a few simple safety tips and precautions, you can prevent most heating fires from happening.

- Have a QUALIFIED professional install stoves, chimney connectors and chimneys.
- Stoves should be listed by a qualified testing laboratory.
- In wood stoves and fireplaces, burn only DRY, seasoned wood. In pellet stoves, burn only dry, seasoned wood pellets.
- Have your chimney and stove INSPECTED and cleaned by a certified chimney sweep every fall just before heating season.
- CLEAN the inside of your stove periodically using a wire brush.
- In order to reduce the potential fire hazard during an earthquake, the stove should be anchored to the floor and stove pipe sections should be secured.
- Use glass doors or a fireplace screen to keep embers inside the fireplace.
- Have a chimney cap installed to keep debris and animals out of your chimney.
- Allow ashes to COOL before disposing of them. Place ashes in a covered metal container. Keep the container at least 10 feet away from the home and other buildings.
- Keep a close eye on children whenever a fireplace, wood stove or pellet stove is being used. Remind them to stay at least 3 feet away from the stove.
- Stoves need space. Keep anything that can burn at least 3 feet away from the stove.
- INSTALL and maintain Carbon Monoxide and Smoke alarms outside each sleeping area and on every level of the home. They should be tested monthly.
- Have your furnace cleaned and check and replace the filters.
- Make sure your space heater has a label showing that it is listed by a recognized testing laboratory. Never leave a space heater unattended. Turn it off when you're leaving a room or going to sleep.
- Heaters must be kept at least 3 feet away from anything that can burn.
- Plug space heaters directly into a wall outlet. Do not use an extension cord or power strip.

## Electric Fencing Not Allowed in PMC

It has come to the attention of the Association that some members are thinking of electric fencing as a means of property protection from wildlife.

The Association has determined that due to liability issues, electric fencing will not be allowed in Pine Mountain Club – Resolution #3-11-17-18. This ruling excludes pet perimeter fencing using buried wiring for containing dogs on your property.

Please note, if Environmental Control Office staff or Patrol Department staff observe these fences on a property, it will lead to citations and possible fines.



## PMC Golf Course Snow Play Rules

We've had some wonderful snow lately, but please remember that the PMC Golf Course must have at least 6" of snow on it before anyone can sled or play on it.

Over the holidays, there were people playing on the course when there was not much snow, only 1-2". They were building a snowman, sledding and driving a golf cart through the snow on the Golf Course. Please do not go onto the golf course after it snows unless there is 6" or more snow on it. This will be monitored closely and people will be asked to leave if less than 6" of snow have fallen.

Here is the official list of Golf Course Snow Play Rules:

1. There must be at least 6 inches of snow on the course for it to be open for play.
2. The driving range, fairways and rough between the fairways are the only areas to be used.
3. No play will be allowed on the Golf Course Greens (flat areas with flagsticks).
4. The Golf Shop and Golf Course Maintenance Personnel will make the determination if the course will be open for play.
5. Please call the Pro Shop or Business Office to confirm prior to snow play.

## Walking While Golfing: Great Way to Stay in Shape

So it's that time of year again when we have all made our New Year's resolutions, only to have kicked those resolutions to the curb by Jan. 2nd. Fear not, in this article, I will tell you why walking the PMC golf course is good for the mind and the body. Let me preface with the fact that I am not a doctor, but through my years golfing, I have picked up tips from people much smarter than I on the subject.

The PMC course, from the back tee boxes, is almost 3,600 yards, or 2 miles. This equates to between 700 and 1,100 calories burned during the time it takes to walk it. A second reason to forego the golf cart is stroke average: walking the course has been said to lower scores by as much as two to three strokes per round. The reason being that your body is much looser and your

body temperature is higher, which equates to more consistent shots. Also, you get to take your mind off of the bad shots for a longer period of time, all the while taking in the scenery we have here at PMC.

If you are one who cannot make it around the whole course walking, try alternating holes with another golfer. You walk Hole One while he or she drives, and then he or she walks Hole 2 while you drive, and so on. It is a win-win for anyone looking to be in better physical and mental health, to lowering their golf scores and to enjoying the great scenery we have here at the course.

## PMC's Snow Berm Removal Procedure

During the winter months, our Association faces many weather-related challenges. The first priority in the event of a snow storm is clearing and sanding the roads of the community. In a nutshell, we have well-established and effective procedures that determine the order in which snow is removed throughout PMC.

The removal of berms from property owners' driveways is provided as a courtesy to members who, in advance, have requested this assistance. In order to be added to this list, you need to present a current ADA placard or doctor's note at the Business Office.

This free service is only provided after snow removal from all Association roads and necessary sanding have tak-

en place. As a result, it could be two or more days before the crews begin to remove berms.

As with the roads, this courtesy service has an established procedure in determining the order in which property owners' berms are removed.

When crews are available to begin berm removal, they will follow the approved ADA berm removal list. Our berm removal list is quite long; and due to limitations of time, equipment and manpower, the process of removing berms for every property owner on the list can take several days, even after the snow has stopped falling.

The berm removal list is intended for the physically impaired.

## Q&A With the GM About Contracts

1. When was the last time the contract for legal council was bid out? Len Segal has been doing it for years. **Answer:** We do not have a contract. It is a Fee Agreement, and either party can cancel at any time.

2. When was the last time the Best Alliance contract was bid out? **Answer:** This is an ongoing contract until either party cancels with 30 days written notice.

3. When was the last time the audit contract with Poindexter was bid out? **Answer:** The last time it was bid out for three years was October 2018. Six RFPs were sent out and only two responded. In November 2015, RFPs were sent to auditors. Only one response was received, which was from Poindexter and Company.

## PMCPOA's Policy on Snowplowing

During winter storms, the Pine Mountain Club Maintenance Department's snowplow equipment will be dispatched as needed to maintain all roadways, cul de sacs and access roads within the PMC community.

This equipment will be dispatched as soon as possible after the snow begins to stick to the road surfaces, and plowing will continue until all of the roads are clear of snow. Cinders will be applied when the Pine Mountain Maintenance Department deems it appropriate.

The streets in our community will be plowed in the following order: First, the main roadways. Second, all access roads. Third, all cul de sacs. And, when time permits, attempts will be made to try to clear snow berms in driveways.

They will respond. Working together we can deal with this. Make sure you know your neighbors. Know when they are here or off the hill. Get their phone numbers and keep an eye open.

Please mark your calendars for Feb. 23. Gwynne Pugh, the architect charged with formulating a phased master plan for future renovations, will present the plan to the Board for review and approval. The meeting will be an open meeting of the Board, and the members are both welcome and encouraged to attend.

The New Year also brings the need to de-

velop a budget for the coming year. Management will provide the first draft of the new budget in late February. The Board will ultimately vote on next year's budget in April.

Just as the New Year marks the development of the budget, it also marks the beginning of the election cycle. There will be three new Board members elected during the annual Members' Meeting in June. Please think about stepping forward and running for the Board. Yes, it is some work, and yes, not everyone will agree with you, but your participation counts and your opinion is important. This is not the time to "let someone else do it." The community needs good people to care and to get involved.

More snow was in the forecast at the time of this writing, and the weather was turning cold again. Looks like a lot more winter ahead! Sounds good to me.

# ----- General Manager's Update -----

As you may be aware, there have been about 12 actual home break-ins in different areas of Pine Mountain Club.

PMC Patrol's primary duty is to protect and preserve the PMCPOA Association, however, Patrol does assist property owners whenever possible. A reminder that PMC Patrol is not a law enforcement agency, nor is it a private community security company. Home security is the responsibility of each individual property owner.

If there is a criminal complaint or any kind of danger, always call 911 first. Then call Patrol second. If it is a situation that Patrol is not permitted to respond to, call them anyway after your 911 call and they will at least come to the area and be good witnesses, take descriptions, etc. to give to the Sheriff when they arrive.

Should you, as a resident of PMCPOA, observe suspicious activity in our community, do not hesitate to notify the police immediately. See Something, Say Something. Safety first.

There is more in this Condor about civil complaints and door-to-door salespeople in the story on Page 1.

We had a large snow event in mid-January and our staff did an excellent job plowing. The plowing crew has a goal to not have even one complaint during snow

storms. I am pleased to announce we had very few calls. A big thank you goes to our plow crew. They are awesome.

When we cinder, we put down enough rock for you to get traction with your vehicles. A lot of members want to see the road red with a lot of cinders before they are comfortable to drive on the roads. This was our first large snow event in many years. We spent \$8,000 on cinders that were put on the roads in one week.

On the Monday night of the snow storm, I am sure many of you saw Facebook. We had a gridlock of vehicles on Mil Potrero Highway. The 5 freeway was closed due to the snow and ice for several hours, so many people came in the back way. Unfortunately, their vehicles were not prepared for the snow and ice on the roads. Also, many of the people in the vehicles were not dressed for snow and ice and the cold weather. Vehicles were in ditches, and cars were spinning out. I am sure you get the picture. It took California Highway Patrol six hours to clear the freeway.

Our community is so awesome in times of need such as this. I want to thank Debra Manoogian, Nancy Dudley, Elaine Salmon, Mr. Kohler, and any others who helped that I don't know about. These folks opened their homes to house the displaced families, to give them a warm place to stay during the night, and to feed them.

Mr. Kohler brought food to the clubhouse, where there were about 30 people getting out of the cold until they could get back on the road. Four men spent the night in the clubhouse. CERT provided them with cots, blankets, sleeping bags and toiletries. Thank you to all the amazing people in PMC who were so kind.

Remember, if you lose power or heat, you can come to the clubhouse. However, you may not bring pets. Sorry.

I cannot stress enough that it is important to be prepared for weather in the winter. Make sure you have the correct tires on your cars. Make sure you carry snow chains at all times. Keep a blanket, water and food in your car when you are traveling. And dress appropriately for the weather.

We are getting ready to head into PMC-POA election season again. I would like to express my thoughts and opinions about the Board of Directors, no matter who is serving on the Board. The Board of Directors doesn't just show up one Saturday a month to make decisions regarding our as-

sociation. They put many hours in every month. Remember, this is a volunteer position. We have one director who is making this her 40-hour-a-week job by reading the Director's Handbook from front to back and doing a lot of research. This director is actively involved in being the best Board member possible. That handbook is at least three inches thick with all of our governing documents and employee handbook.

Directors do a lot of research on their own with Civil Codes, Corporation Law, etc. Some Board members want to be on the Board for their own personal agenda. Some come on because they feel a calling for civic duty. Both of those reasons are very legitimate. Both groups will learn why the Association operates the way it does, based on Civil Code, laws and governing documents. Being a director is a continuing learning process. You know the adage about people who don't have chil-

dren telling people with children how to raise them. Members can think they know everything about running an association, but once you get on the Board, you learn so much that you didn't know. Every director has a huge responsibility to the association that should be taken very seriously.

If you plan to run for the Board, remember: "A community association is no better than the Board of directors that leads it. If an association is to be excellent, willing volunteers must be developed. Truly exceptional volunteer governance is not a happy accident, and it often has little to do with a volunteer's background, training, and experience. Instead, it is the result of hard work and the pursuit of proper values, foundational understandings, and perspectives."
